Since we are not Catholics, we are concerned only with the safety and effective ness. Janice prefers to use the new, oral contraceptives and we would appreciate your personal opinion as to the safety of the oral contraceptive pill, which one you would recommend, how long they may be used with no probable side effects as they do not plan a family for a few years.

If you feel there is a special oral contraceptive that is best, perhaps you would enclose a prescription that we could get filled up here. Is it advisable to take the pills the month previous to marriage to accustom one's body to the pills? If so, she would have to take them following her November period, about November 12.

Thank you for your kindness in this matter. I thought you said you were going to take a trip to Alaska when I was in there for a physical a few years back.
