Dear Dr. Brougher:-

I have had occasion to read your article on "The Present Status of Calcium Therapy" in the January, 1929, issue of The Medical Sentinel. I was greatly pleased with your resumé of the subject, which is one to which I have myself given a great deal of attention, but from a little different angle. I am disposed to think that altogether too much stress has been laid on calcium per se. While I do not question the value of calcium therapy, I do feel that it should not be so much separated from that of phosphorus- that these two go hand in hand and that the degree of the retention of one is closely knit with the retention of the other.

My interest in the subject has been in connection with the feeding of minerals apart from those found normally in food, both in cases where pathological lesions exist as well as where no marked lesions are evident. The mineral material in which I am interested has been subjected to quantitative human metabolism experiments and to three years of clinical work and with splendid results. So you may readily understand my interest in your article, dealing as it does with the general field of calcium therapy.

If you have a reprint of your article available, I shall be pleased to receive one for my files.

I would like to take this opportunity to extend my congratulations to you as the new President of the University of Oregon Medical School Alumni Association.

Doctor Donald Olson suggested that I write a letter to you which could be considered at a meeting of your executive council. I realize that you will have no meeting until the Fall but since it is in my thoughts, I would like to suggest at this time a new project for our Alumni Association.

I have felt that every project that the association has sponsored from the early travel fund for faculty members down to the presently much enlarged and expanded appropriation, have all been of great benefit.

The challenge I would like to propose concerns a Medical Museum. There have been small displays in the library at times, and there is a medical history room, but what I'd like to see is a real medical museum, with suitable and adequate display cases for a permanent collection of materials which would tell the story of medicine in the Oregon Country from the Indian medicine doctor, often called the Shaman, with his knives of stone, his cupping horns, and other forms of witchcraft, on to the pioneer herb doctor, the patent remedy dispenser, the age of electric magnetism, et cetera, only to mention a few stages in the history of medicine.

Support for such a project would need funds other than from the Alumni Association, and it is possible that some foundation would consider a matching fund.

If the Council is favorable towards pursuing the possibilities of such a project, and would care to have me meet with sometime, I would be happy to do so.
