

**Certificate of Filing Supplementary Articles  
of Incorporation**

To All to Whom These Presents May Come, Greeting:

Know Ye, That whereas

PACIFIC COLLEGE

a nonprofit corporation organized and formed under and pursuant to the Laws of the State of Oregon, having presented Supplementary Articles of Incorporation, and paid the filing fee, as provided by law;

Now Therefore, I, Maurice Hudson, Corporation Commissioner of the State of Oregon, DO HEREBY CERTIFY, that said

**Supplementary Articles of Incorporation**

have been filed in the office of the Corporation Commissioner the 16th day of November, 1949. The first article of the original Articles of Incorporation of said Pacific College made on the 22nd day of November, 1894, and filed in the office of the Secretary of State of the State of Oregon, on the 22nd day of January, 1895, is hereby amended to read as follows:

ARTICLE I.

The name assumed by this corporation and by which it shall be known is "George Fox College".

I Further Certify, that said Supplementary Articles of Incorporation were accompanied by a fee of Five Dollars (\$5.00).

In Testimony Whereof, I have hereunto set my hand and affixed hereto the seal of the Corporation Department of the State of Oregon, at Salem, this 16th day of November, 1949.
