Dear Doctor Brougher:

This is to extend to you my personal invitation to the Postgraduate Course in Obstetrics & Gynecology here in Seattle on December 1, 2, and 3, 1965.


As you will note on the enclosed program, this is a two and a half day course which is unique because 1) the topics are to be presented only by the guest faculty, 2) demonstration of practical office and hospital procedures on Thursday morning, and 3) there will be ample time allowed for you to ask questions. The faculty includes five guest instructors who are nationally known as outstanding teachers.

On Thursday morning, new, practical, clinical procedures will be demonstrated in small groups. We hope to have no more than 10 in each group, enabling close observation and discussion of the procedures. It is hoped that many or all of the demonstrations can be included for each individual. The following demonstration of techniques will be: amniocentesis for obtaining fluid for Rh determination, fetal heart monitoring for the office, insertion of intrauterine devices, culdoscopy, blood volume, pregnancy and coagulation tests, Achilles tendon reflex tests for evaluation of thyroid status.

I need your support in making this a successful course, and I hope to see you here in December.

I too hope that the New Year will be filled with good things.

I note that the manuscript on Bellergal is in the hands of Northwest Medicine. Shall keep my fingers crossed.

Early this year we plan to introduce Mellaril (3-methylmercapto-10- β -N-methyl-piperidyl-2")-ethyl-1 β -phenothiazine-hydrochloride), which looks most promising as a tranquilizing agent, judging from the numerous and extensive studies in this country and abroad. It is a phenothiazine and in 4,000 or more cases, no Parkinsonism has been reported, no usual extrapyramidal symptoms and no cases so far of blood dyscrasia or liver damage. Can you evaluate it for anxiety and tension?
