4/13 - WILLAMETTE 4, GEORGE FOX 2: Bruins Drop NWC Tournament Play-In Match to Bearcats

SALEM, Ore. - Although George Fox University will be the host institution for the Northwest Conference men's and women's tennis tournaments Apr. 16-17 in Yakima, Wash., the Bruin men's team will not be playing in it after dropping the tournament play-in match 4-2 to the Willamette University Bearcats here Tuesday afternoon.

The Bearcats finished 8th and the Bruins 9th in the regular season, but only eight teams go to the tournament, so the bottom two clubs usually play off to see which team gets to go. Willamette earned its way there by taking four of the six singles matches that were played before the doubles in case of inclement weather. The doubles matches were cancelled since the match had already been decided.

The Bearcats got victories by Matt McManus over Matt Leininger at #1, Garrett Nakamatsu over Kyle Pearson at #2, Jeff Hancock over Chris Selid at #5, and Josh Barnett over Bryan Gray at #6. Bruin wins came from their two seniors, Derek Dougherty over Andy Frey at #3, and Yu Shoji over Jeff Garrison at #4.

George Fox ends its season at 1-13, while Willamette advances to the NWC Tournament with a 2-8 record. Pairings for the first round of both the men's and women's tournaments will be announced following the NWC coaches' meeting Thursday evening in Yakima.

4/12 - George Fox to Host NWC Tennis Championships Apr. 16-17 at Yakima Tennis Club

NEWBERG, Ore. - George Fox University will serve as the host institution for the 2004 Northwest Conference Men's and Women's Tennis Championships coming up Friday-Saturday, Apr. 16-17, in Yakima, Wash.

The majority of matches, including the finals, will take place at the Yakima Tennis Club, which features both outdoor and indoor courts. A few early-round matches will be held at the West Valley and Selah High School courts. Play gets under way Friday at 8:00 a.m. with the first women's matches, while the finals in both divisions are set for 12:00 noon Saturday.

While the regular season has concluded for all teams, the brackets will not be determined until the NWC coaches' meeting Thursday night. This is due to the fact that the NWC does not play a full round-robin schedule, but only a round-and-a-half, and coaches will use several criteria in addition to head-to-head competition to determine seedings. Also, the men's teams from George Fox and Willamette University are to have a play-off match on Tuesday, Apr. 13, at 3:30 p.m. in Salem, Ore., for the eighth and final spot in the men's division.

Linfield College will be seeking its third straight NWC championship in both the men's and women's divisions. The stiffest challenges for the Wildcat men (8-9, NWC 8-2) are expected to come from Pacific Lutheran University (11-6, NWC 10-1) and Whitman College (12-6, NWC 9-1). The Linfield women (15-5, NWC 11-0) could be looking over their shoulders at the University of Puget Sound (13-3, NWC 10-2) and Whitman (10-5, NWC 8-3).

4/10 - PACIFIC LUTHERAN 7, GEORGE FOX 0: Bruins Blanked by Lutes in Regular-Season Finale

TACOMA, Wash. - Bringing a tough regular season to a close but still hoping to gain a berth in the Northwest Conference Championships, the George Fox University Bruins bowed out with a 7-0 setback to the Pacific Lutheran University Lutes in a men's tennis match Saturday morning here on the PLU courts.

The Lutes took all 9 matches, starting with the doubles as Matt Larimore and Luke Roloff downed the Bruins' Derek Dougherty and Kyle Pearson at #1, Erik Husa and Jeff Loranger dropped Chris Selid and Matt Leininger at #2, and Dave Edmiston and Boyd Massie blanked Yu Shoji and Bryan Gray at #3.

Singles wins for PLU went to Roloff over Leininger at #1, Husa over Dougherty at #2, Loranger over Pearson at #3, Massie over Shoji at #4, Edmiston over Selid at #5, and Kevin Yoder over Gray at #6.

George Fox ends at 1-12 overall and in the conference, while Pacific Lutheran is 11-6 overall and 10-1 in the NWC. PLU earns the top seed in the NWC Championships Apr. 16-17 in Yakima, Wash., hosted by George Fox. However, for the Bruins to get there, they must, as the 9th-place team in the conference, have a playoff match for the 8th and final spot against either Willamette University or Pacific University on Tuesday.

4/9 - PUGET SOUND 7, GEORGE FOX 0: Bruins Fall to Loggers Again in Second Match at **Puget Sound**

TACOMA, Wash. - In a quirky bit of scheduling, George Fox University was to play the University of Puget Sound twice this year in Tacoma in men's tennis, instead of home-and-home, and the results were about the same as when they opened the season here on Feb. 14, the Bruins falling to the Loggers 7-0 in a Northwest Conference match.

The Loggers captured all the matches, starting with a 3-0 sweep of the doubles. Trent Neugebauer and Travis Titus defeated Derek Dougherty and Kyle Pearson at #1, Jeff Belzer and Andrew Gemmer won over Matt Leininger and Chris Selid at #2, and Samuel Ziff and Noah Swanson downed Yu Shoji and Bryan Gray at #3.

In singles, it was Rogers Hawley over Leininger at #1, Neugebauer over Dougherty at #2, Swanson ove Pearson at #3, Belzer over Shoji at #4, Aaron Fung over Selid at #5, and Ziff over Gray at #6.

George Fox dropped to 1-11 overall and in the conference, while Puget Sound improved to 9-6 overall and 7-5 in league play.

WALLA WALLA, Wash. - In a morning match with the Whitman College Missionaries, who were scheduled against NAIA powerhouse Lewis-Clark State later in the afternoon, the George Fox University Bruins fell 6-1 in Northwest Conference men's tennis here Saturday on the Whitman outdoor courts.

The Bruins' lone win came at #3 singles as Kyle Pearson scored a 7-6 (7-3), 4-6, (10-2) win over Will Wyatt. Whitman singles winners were Brad Changstrom over Matt Leininger at #1, Sam Spiegel over Derek Dougherty at #2, Daryl Gasca over Yu Shoji at #4, Kenji Strait over Chris Selid at #5, and Aaron Cho over Bryan Gray at #6.

SPOKANE, Wash. - With their final four regular-season matches on the road, the George Fox University Bruins got off to a rough start on their two-game swing through eastern Washington, falling 6-1 to the Whitworth College Pirates in Northwest Conference men's tennis Friday afternoon here at the Whitworth courts.

NEWBERG, Ore. - Needing a win over Willamette University to stay a step ahead of the Bearcats in the Northwest Conference men's tennis standings, the George Fox University Bruins instead fell a game behind the Bearcats and into 9th place with a 5-2 loss Thursday afternoon here at the GFU campus courts.

The visiting Bearcats got a jump on the Bruins by sweeping all three doubles matches to earn the doubles point, with wins going to Matt McManus and Shaun Mihalick at #1, Jeff Garrison and Garrett Nakamatsu at #2, and Andy Frey and Jeff Hancock at #3.

The Bearcats then sealed the win by taking four of the six singles matches. McManus at #1, Nakamatsu at #2, Hancock at #4, and Josh Barnett at #6 secured victories for Willamette, while George Fox got wins from Kyle Pearson at #3 and Yu Shoji at #6.

NEWBERG, **Ore.** – Making up a match that was rained out on Feb. 28, the visiting Whitworth Colelge Pirates made off with a 7-0 victory over the home-standing George Fox University Bruins in Northwest Conference men's tennis action Saturday morning here at the GFU campus courts.
