2. SUMMARY: I TOLD UGANDAN FOREIGN MINISTER SSEMOGERERE JUNE 20 IN PARIS THAT WE KNOW THE GOU PROVIDES THE RPF SIGNIFICANT SUPPORT, ENABLING IT TO KEEP WAGING WAR IN RWANDA. I TOLD HIM THIS SENSELESS FIGHTING MUST STOP. I ADDED THAT IF THERE IS NEITHER PEACE NOR, AT A MINIMUM, A CEASEFIRE IN PLACE BY OCTOBER 1, 1992, WE WILL BEGIN DEDUCTING FROM THE AID WE GIVE TO UGANDA THE COSTS OF OUR RELIEF FOR THE VICTIMS OF THE WAR. I REQUEST THAT YOU DELIVER THE LETTER BELOW, REITERATING THESE VIEWS, DIRECTLY TO PRESIDENT MUSEVENI. END SUMMARY.

### BACKGROUND

3. DURING THE LARGER MEETINGS IN PARIS LAST WEEK (REFTEL) BETWEEN THE FRENCH, THE GOR, THE GOU, AND MYSELF, IT WAS CLEAR TO ME THAT FOREIGN MINISTER SSEMOGERERE WAS NOT FREE TO SPEAK HIS MIND. HE WAS SURROUNDED BY A GROUP OF NRA OFFICERS, NOT DIPLOMATS, ONE OF WHOSE MAIN PURPOSES SEEMED TO BE TO MAKE SURE THAT HE NOT DEPART FROM THE OFFICIAL CONFIDENTIAL

GOU LINE. THUS, EACH TIME THE FRENCH POINTED OUT THAT
THERE IS NO WAY THE RPF CAN OPERATE ON THE SCALE THEY DO
WITHOUT OUTSIDE SUPPORT, AND THAT THIS SUPPORT HAS TO COME
CHIEFLY FROM UGANDA. SSEMOGERERE RETORTED LAMELY THAT
THERE WAS NO "PROOF."

4. I THEREFORE DECIDED TO SPEAK FRANKLY TO THE FOREIGN MINISTER WHEN WE HAD A OPPORTUNITY TO MEET IN A SMALLER GROUP, WITHOUT THE CLUTCH OF NRA CADRES. I TOLD HIM THAT WE KNOW WITHOUT DOUBT THAT THE GOU PROVIDES THE RPF SIGNIFICANT SUFPORT, ENABLING THEM TO WAGE THIS SENSELESS WAR, WHICH COSTS US (IN RELIEF FOR THE DISPLACED AND THE LIKE) AS WELL AS THE COUNTRIES OF THE REGION AND THREATENS TO DESTABILIZE THE ENTIRE REGION. I SAID THE WAR MUST STOP SOON. I TOLD SSEMOGERERE THAT IF THERE IS NEITHER PEACE, NOR, AT A MINIMUM. A CEASEFIRE AGREEMENT IN PLACE OCTOBER 1, 1992, WE WILL START DEDUCTING FROM THE AID WE GIVE TO UGANDA THE COST OF OUR RELIEF FOR THE VICTIMS OF THE WAR (NOT/NOT, AS STATED ELSEWHERE, THE COST OF MAINTAINING A BORDER VIOLATION UNIT). THE FOREIGN MINISTER SAID THAT HE PERSONALLY WELCOMED THIS NEWS, AND CONFIDED THAT HE ONLY WISHED THAT MUSEVENI HAD A CHANCE TO HEAR IT DIRECTLY. I THEREFORE WOULD LIKE YOU TO CONVEY

TO PRESIDENT MUSEVENI AS SOON AS POSSIBLE THE FOLLOWING LETTER. THE SIGNED ORIGINAL FOLLOWS BY POUCH.

BEGIN TEXT:

DEAR MR. PRESIDENT:

I REGRET I DID NOT HAVE THE OPPORTUNITY TO MEET WITH YOU CONFIDENTIAL

WHEN YOU WERE IN WASHINGTON, AS I WAS OUT OF THE COUNTRY.
I DID MEET. HOWEVER. LAST WEEK WITH FOREIGN MINISTER
SSEMOGERERE IN PARIS, WITH WHOM I RAISED CANDIDLY OUR
CONCERNS ABOUT RWANDA AND THE RPF. I WISH TO SHARE THESE
DIRECTLY WITH YOU.

YOU TOLD ME LAST MONTH IN KAMPALA YOU WOULD USE YOUR INFLUENCE TO HELP END THE RWANDA CONFLICT. SINCE THEN. THE FIGHTING HAS INTENSIFIED, WITH POTENTIALLY GRAVE CONSEQUENCES. THE LONGER THE WAR LASTS, THE GREATER THE

CHANCE THAT RWANDA AND THE LARGER REGION--INCLUDING . UGANDA--WILL BE DESTABILIZED.

THIS FIGHTING IS ALL THE MORE UNNECESSARY, SINCE THE DEMOCRATIZATION PROCESS IN RWANDA AND RWANDA'S NEW GOVERNMENT OFFER THE RPF THE BEST CHANCE IT HAS HAD SO FAR TO GAIN SATISFACTION OF ITS LEGITIMATE GRIEVANCES THROUGH NEGOTIATIONS. THE CONFLICT, MOREOVER. DRAINS NOT ONLY THE RESOURCES OF THE REGION, BUT THOSE OF THE INTERNATIONAL COMMUNITY AS WELL. THE LATTER, AND THE UNITED STATES IN PARTICULAR, FACE ESCALATING REQUIREMENTS FOR RELIEF TO REFUGEES AND OTHER VICTIMS OF THE WAR.

UNFORTUNATELY, IT HAS BECOME CLEAR THAT YOUR GOVERNMENT BEARS A DIRECT RESPONSIBILITY IN THE CONTINUATION OF THE FIGHTING. THE RPF SIMPLY CANNOT WAGE WAR ON SUCH A SCALE WITHOUT OUTSIDE HELP, AND THE BULK OF THE EVIDENCE INDICATES THAT MOST COMES FROM UGANDA. A FEW WEEKS AGO, I EXPRESSED TO YOU MY GOVERNMENT'S SATISFACTION AT THE COMMITMENT YOU HAD EXPRESSED TO HELP BRING ABOUT PEACE.

NOW I MUST EXPRESS OUR DEEP CONCERN THAT, DESPITE THIS COMMITMENT, UGANDA'S ACTIONS TURN OUT TO BE PROMOTING WAR, NOT PEACE.

FOR THE BENEFIT OF THE ENTIRE REGION, THIS WAR MUST END SOON. IF A PEACEFUL SETTLEMENT HAS NOT BEEN REACHED, OR AT A MINIMUM, IF A FIRM CEASEFIRE IS NOT IN PLACE BY OCTOBER 1, 1992, WE WILL HAVE NO CHOICE, GIVEN THE BURDEN THE CONFLICT PLACES ON U.S. RESOURCES, BUT TO DEDUCT WHAT IS NEEDED FOR RELIEF FOR RWANDA'S DISPLACED FROM THE ECONOMIC ASSISTANCE WE PROVIDE TO UGANDA.

MR. PRESIDENT, YOU STATED TO ME YOUR UNEQUIVOCAL COMMITMENT TO PEACE. YOU REITERATED IT IN YOUR CONVERSATIONS WITH MY DEPUTY, DEPUTY ASSISTANT SECRETARY ROBERT HOUDEK, IN WASHINGTON LAST WEEK. I URGE YOU TO DO THE NECESSARY TO PUT THIS COMMITMENT INTO PRACTICE, BY STOPPING THE FLOW OF UGANDAN ASSISTANCE TO THE RPF AND USING YOUR INFLUENCE WITH THE RPF TO ENSURE THAT THEY NEGOTIATE SERIOUSLY AND ACCEPT A CEASEFIRE. I URGE YOU, IN PARTICULAR, TO PRESS THE RPF TO COME TO THE JULY 10 TALKS WITH CONCRETE PROPOSALS FOR A CEASEFIRE. WE WILL DO OUR PART TO CONVINCE THE RWANDAN GOVERNMENT TO DEAL DIRECTLY WITH THE LEGITIMATE CLAIMS OF THE RPF AND THE RWANDAN REFUGEES TO RETURN TO RWANDA AND PARTICIPATE IN A DEMOCRATIC SOCIETY.

UNDER YOUR LEADERSHIP, UGANDA, BREAKING WITH ITS UNHAPPY

PAST, HOLDS THE PROMISE OF BECOMING ONCE AGAIN A FORCE FOR PEACE AND STABILITY IN THE REGION. I URGE YOU NOT TO CONFIDENTIAL
