SUBJECT: HON. AGARD DIDI'S IMPRESSION OF THE RWANDA

CONFLICT AND PROPOSED REMEDIES.

- 1.1 HON. DIDI ACCOMPANIED THE 2ND DEPUTY PRIME MINISTER/
 MINISTER OF FOREIGN AFFAIRS HON. SSEMOGERERE TO
 RWANDA ON AN OFFICIAL VISIT AT THE INVITATION OF
 THE HOST COVERNMENT. AFTER TOURING RWANDA HE
 NADE THE FOLLOWING OBSERVATIONS.:-
- 1.2 SINCE THE START OF THE WAR RWANDA HAS DEPLOYED

 MASSIVE MANPOWER ON ALL THE STRATEGIC HILLS ALONG

 THE RWANDA UGANDA BORDER. THE POPULATIONS ARE

 WELL-DRUMMED WITH ANTI-RPF, ANTI-TUTSI AND ANTI
 UGANDA GOVERNMENT RHETORIC.

 IT IS ALMOST SAFE TO CONCLUDE THAT THE RPF CANNOT

 WIN THE WAR GIVEN THE PSYCHOLOGICAL BRAIN-WASHING

 OF THE POPULATION.
- 1.3 MUCH CASE IS BEING MADE OF UGANDANS, AND IN

 FARTICULAR THE BAHIMA TRIBE, OF SUPPORT AND

 SYMPATRY FOR THEIR FELLOW PASTORALISTS, THE

 BATUTSI.
- 1.4 THE ARGUMENT ABOUT LACK OF LAND TO RESETTLE THE REFUGEES IS A PRETEXT TO DENY THE TUTSI ENTRY.
- 1.5 RWANDA ACCUSES UGANDA NOT ONLY FOR PROVIDING

 MILITARY WARES TO THE RPF BUT ALSO FOOD AND

 SANCTUARY, FOR THE LOCAL POPULATION INSIDE RWANDA

 AS

 IS UNSUPPORTIVE OF THEM OR IF ANYTHING FEAR THE

 ATROCITIES THEY COMMIT.

- 1.6 THE MAJOR EUROPEAN AND AMERICAN EMBASSY OFFICIALS
 APPEAR ALL TOO CONVINCED ABOUT UGANDA'S COMPLICITY
 IN SUPPORT OF THE RPF.
- 1.7 THE TUTSI LEADERSHIP IS BEING CALLED PROTESTANT

 LED AND THE CATHOLIC CLERGY SEEM TO BE USING THIS

 AS A RALLYING POINT OF THE PREDOMINANTLY CATHOLIC

 HUTUS.
- 1.8 IN THE TRANSPORT SECTOR, RWANDA NOW USES THE ROUTE
 THROUGH TANZANIA AND IS DESPERATELY LOOKING FOR
 ALTERNATIVE ROUTES TO UGANDA BECAUSE THEY BELIEVE
 THAT THE TUTSI LOBBY IN UGANDA MAY MAKE AN EARLY
 NORMALISATION DIFFICULT.

2. PROPOSALS

- 2.1 THE TWO LEADERS SHOULD NEET PRIVATELY AND CONFIDENTIALLY, WITHOUT THIRD PARTY INTERMEDIARIES, TO RE-ESTABLISH MUTUAL CONFIDENCE AND TACKLE ISSUES OF TENSION. REAL OR APPARENT.
- 2.2 UGANDA SHOULD SERVE AS AN EXAMPLE TO SHOW HOW

 DIVERSE MILITARY AND POLITICAL FORCES CAN BE MADE

 TO WORK TOGETHER AND HELP EASE THE RWANDA FEAR OF

 PROPING THE TUTSI FOR LEADERSHIP ONLY.
- 2.3 THE BORDER SHOULD BE EXPEDITIOUSLY OPENED AND
 ESCORTS PROVIDED FOR ALL TRANSIT CARGO SO AS TO
 FORSTER GREATER CONFIDENCE ON THE LIFE-LINE ROUTE.

2.4 UGANDA SHOULD SUPPORT THE KBO BY CLEARING ITS ARREARS NOW STANDING AT OVER US\$ 2 MILLION.

3. CONCLUSION

- 3.1 IT IS THE BELIEF IN RWANDA THAT YOUR EXCELLENCY
 ALONE WAS THE STATURE AND CAPACITY TO EXERT THE
 GREATEST INFLUENCE OVER THE WAR AT THE BORDER AND
 THE BEST PLACED PERSON TO INFLUENCE THE RPF LEADER—SHIP.
- 3.2 IF THE PAPER APPEARS PRO-RWANDA, HON. DIDI INTENDED IT TO BE SO THEREBY PIN-POINTING THE AREAS THAT IF ADDRESSED COULD NOT ONLY ANSWER THE RWANDA ACCUMATIONS BUT ALSO PRESENT UGANDA'S CASE TO WHAT APPEARS TO BE A BIASED WORLD ASSESSMENT.
