Fitchett, G., White, K. B., & Lyndes, K. (Eds.). (2018). *Evidence-Based healthcare chaplaincy: A research reader*. Philadelphia, PA. Jessica Kingsley Publishers. 432 pp. \$34.86 ISBN 9781784509231

George Fitchett is professor and Director of Research in the Department of Religion, Health, & Human Values at Rush University Medical Center. He has been a certified chaplain and educator for over 30 years. Kelsey B. White is an experienced chaplain and research fellow of the Transforming Chaplaincy Project. She is currently working on her doctoral degree in Health Management and Public Policy at the University of Louisville. Kathryn Lyndes is an Assistant Professor and Coordinator of the Transforming Chaplaincy Project in the Department of Religion, Health and Human Values at Rush University Medical Center.

Research literacy is now required for board certified chaplains in the U.S. This research reader is a broad sampling of current healthcare chaplaincy research. It contains 21 research articles based around three themes: healthcare chaplains: where they work and what they do; patient/family spiritual needs and their spiritual care interests; and chaplaincy interventions and their impact. Most articles include: Abstract; Keywords; Background; Methods; Cases; Assessments; Results; Discussion; Conclusions; References.

This paperback is geared for being a textbook in healthcare chaplaincy research. The very scholarly introduction supports the concept of using an evidence-based paradigm. It explains why these specific articles were selected and where to find additional research. The introduction has a two-page list of references, and the articles each have many references, but, this book does not include any appendices or indexes. It is mostly a scholarly and scientific academic writing without focusing on any particular religious, spiritual or theological stance. The articles consist of doctoral-level research and analysis from peer reviewed scholarly journals. The book achieves its purpose of introducing evidence-based research articles for practicing and future chaplains. And it contributes to the field of study.
