James Calvin Keene, a member of Lewisburg, PA Meeting, now in his 82nd year, received his A.B. from Lebanon Valley College in 1930, his Ph.D. from Yale University in 1937. The three years prior to his doctoral work he taught at the International College in Izmir, Turkey (1931–1934). There he met his wife, Elsa. He taught in Colgate University (1937–1943). During the following 15 years he occupied the Jesse Holmes Memorial Chair in the Howard University School of Religion. During a year of sabbatical leave (1949–1950) he was professor in the American University of Beirut, in Lebanon. He is Emeritus (since 1974) Professor of Religion at St. Lawrence University (where he taught from 1958 to 1974). He edited a standard text, *The Western Heritage of Faith and Reason* (New York: Harper, 1963). A member of the American Academy of Religion and of the American Theological Society, he was vice-president of the latter (1963–1964) and secretary (1964–1972). A founding member of QTDG, he was the first Editor of *QRT* (1958–1963).

A convinced Friend and a member of Lansdowne Monthly Meeting (PhilaYM), **Mary Moehlman** has an M.Ed. in educational psychology from Temple University and an M.Div. from the Earlham School of Religion. A former editor of the *FGC Quarterly*, Mary Moehlman has traveled widely among U.S. and British Friends leading seminars, retreats, and workshops. A participant in the Quaker Studies Program of Philadelphia Yearly Meeting, she also taught Quakerism 101. In NYYM's Quaker Studies Program, Mary Moehlman taught in the Bible section.

Interest in the World Religions took an unusual twist for **Daniel A. Seeger**. After reading Gandhi in a required college course on "contemporary civilization," he became a conscientious objector to military service during the Korean War. This ultimately led to the United States Supreme Court, where a unanimous decision in *USA vs. Seeger* greatly broadened the basis for conscientious objection. Daniel Seeger is Regional Executive Secretary of the New York Office of the American Friends Service Committee, where he joined the staff in 1962 some years after he had first been led by the telephone

directory to draft counseling there. He became a Friend in 1967 and is a member of the 15th Street Meeting in New York City.

Douglas Gwyn needs no introduction to regular readers of *QRT*. A fairly complete note appears in *QRT* #70. As this goes to print he continues to be Scholar in Residence at Pendle Hill. He was beginning a six-week postoperative recuperation period following a ruptured appendix. Help him keep his workload light.
