Contributors

Maurice A. Creasey is Director of Studies at Woodbrooke, the Quaker college in the Selly Oak group of colleges in Birmingham, England. He is an Honors Graduate of London University, King's College, in mediaeval and modern history; and from the University of Leeds he received the degrees of B. D. and Ph. D., in the pursuance of which he made a special study of the theology of Robert Barclay and of early Quaker Christology. He is a member of the Faith and Order Commission of the World Council of Churches and of the Faith and Order Department of the British Council of Churches. For five years he was Clerk of the London Yearly Meeting's Committee on Christian Relationships.

Lewis Benson is a frequent contributor to the columns of this magazine, both as writer of a main article in the issue of Spring 1960, and as critic. He is also a member of the Editorial Board and one of the founders of the Quaker Theological Discussion Group. A member of Central Philadelphia Monthly Meeting and Powelton Preparative Meeting, he was a Fellow at Woodbrooke in 1954-1955, and has lectured at both Woodbrooke and Pendle Hill. He appears as critic in this issue at the special request of Maurice Creasey.

J. Floyd Moore took degrees at Guilford College, Hartford Theological Seminary, and Boston University. His doctoral thesis at Boston University dealt with the ethical thought of Rufus Jones. He studied also at Pendle Hill, and Swarthmore and Haverford Colleges. He taught in the Friends Boys School in Ramallah, Jordan, and did relief work under the American Friends Service Committee in Germany. Active among Friends primarily in North Carolina, Pennsylvania, and New England, he is a member of the executive committee of the Friends World Committee and is president of the North Carolina Teachers of Religion. Since 1944 he has been a member of the faculty at Guilford College, where he is at present associate professor of biblical literature.

David O. Stanfield is executive secretary of the Five Years Meeting Board on Stewardship and Finance. During the 14

years preceding his accepting this assignment in 1961 he served Friends as a pastor in meetings in Ohio and North Carolina and as executive secretary of the Wilmington Yearly Meeting in Ohio. He graduated from Baltimore Friends School, Guilford College, and Hartford Theological Seminary, and has been active in the work of the Five Years Meeting and the American Friends Service Committee. In 1952 he attended the Friends World Conference in Oxford, England.
