PAUL N. ANDERSON serves as Professor of Biblical and Quaker Studies at George Fox University and as Extraordinary Professor of Religion at the North West University of Potchefstroom, South Africa. Author of Following Jesus: The Heart of Faith and Practice and the Epilogue to Walter Williams, The Rich Heritage of Quakerism, Paul's most recent books include: John and Judaism: A Contested Relationship; John, Jesus, and History, Vol. 3, Glimpses of Jesus from the Gospel of John; and From Crisis to Christ: A Contextual Introduction to the New Testament. Paul served as editor of QRT from 2000-2011, and he currently edits the Biblical Interpretation Series (E.J. Brill), the Johannine Monograph Series (Wipf & Stock), and the Quakers and the Disciplines Series (FAHE).

JEFFREY DUDIAK is Professor of Philosophy at The King's University in Edmonton, Canada, and adjunct Professor of Philosophy at the University of Alberta. He has been the Cadbury Scholar at Pendle Hill and has served as clerk of the Friends Association for Higher Education. His book on the relationship between Quakerism and Christianity, *Radicalizing Spirit*, was published by Friends United Press in 2015.
