### **2/1 - GEORGE FOX 5, CAL TECH 4: Bruins battle Back to Win Five Singles and Match vs. Cal Tech**

**PORTLAND, Ore.** - Despite dropping all three doubles sets to start the match, the George Fox University Bruins rallied to win five singles matches and pull out a 5-4 victory over the California Institute of Technology Beavers in women's tennis Saturday afternoon (Feb. 1) here at the Lewis & Clark College indoor courts.

It was the earliest start to a season for the Bruins, who are coming off their best record ever at 8-9 last year.

The Bruins captured the top five singles matches, with wins going to returning players Lisa Trefts, Stephanie Selid, Kristin Miller, Heidi Stagge, and Keri Ingraham.

The Bruins are off until Friday, Feb. 14, when they will entertain Southern Oregon University in a neutral-site match at the Tualatin Hills Tennis Center in Beaverton at 6:00 p.m.

### **2/14 – SOUTHERN OREGON 7, GEORGE FOX 2: Bruins Suffer First Setback of Season to Southern Oregon**

### **2/22 -- LEWIS & CLARK 9, GEORGE FOX 0: Bruins Fall to Pioneers in First NWC Match of Season**

**NEWBERG, Ore.** -- After being rained out against Pacific University last weekend, the George Fox University Bruins finally got their Northwest Conference women's tennis season under way and dropped a 9-0 decision to the Lewis & Clark College Pioneers Saturday afternoon (Feb. 22) here at the GFU campus courts.

The match had been scheduled for 10:00 a.m., but did not get started until almost 2:00 p.m. due to wet courts. The Pioneers swept through the match with the loss of only one set, Keri Ingraham winning the first set in the #5 singles for the Bruins before losing the set eventually in a tiebreaker.

### **3/1 - PUGET SOUND 6, GEORGE FOX 3; Doubles Defeats Put Bruins in Early Hole in Loss to Loggers**

**NEWBERG, Ore.** - After dropping the three opening doubles matches, the George Fox University Bruins battled back to split the singles matches but fell 6-3 to the University of Puget Sound Loggers in Northwest Conference women's tennis action Saturday (Mar. 1) here at the GFU campus courts.

George Fox got singles wins from #1 Lisa Trefts, #2 Stephanie Selid, and #5 Keri Ingraham, while Puget Sound got wins from Ali Mathieu at #3, Molly Clevenger at #4, and Nicole Sherwood at #6.
